ON THE APPLICATION of the Petitioner City of New Westminister without a hearing and by consent;


THIS COURT ORDERS that:

1. The Order of the Office of the Information & Privacy Commissioner F14-50 (2014 BCIC 54) is quashed, and the matter is referred back to the Registrar of the Office of the Information & Privacy Commissioner to schedule a new Inquiry of this matter.
2. The Office of the Information & Privacy Commissioner retains full jurisdiction to deal with the matter in accordance with its process, provided that:
  1. Any adjudication shall be *de novo* by a different adjudicator than the adjudicator who made Order F14-50;


- II. Either party to the new Inquiry may rely on some or all of the materials filed in the original Inquiry of this matter, and may file additional submissions and evidence in accordance with the schedule set by the Registrar; and
- III. The issue of harm claimed to be suffered by the City of New Westminster will be considered as at the date of the new Inquiry.


3. The parties shall bear their own costs.


